Town Board Meeting; Wednesday, May 11, 2022

BOARD PRESENT: Chair Tom Jacobs, Supervisors Andy Neubauer and Kevin Timm

STAFF PRESENT: Clerk Jill Murphy and Treasurer Danny Kjos

Call to Order: Chair Jacobs called the meeting to order at 7:02 p.m. Notices were posted.

Minutes: Motion by Timm/Neubauer to approve the minutes of April 13 Town Board Mtg. **Motion** carried unanimously.

Treasurer's Report: April 2022 financial report was presented. Motion by Neubauer/Timm to approve. **Motion** carried unanimously.

Shelby Fire Department: Chief Holinka stated there were 5 calls in April from Greenfield with a response time of 2.5 min. Dept. assisted in the recent La Crosse fire while maintaining staff to cover their area. Attended conference to look at new equipment and swift water rescue gear. Had auto extrication training at the town hall. 2 members who reside in Greenfield left the dept. Chief Holinka gave a speech at the Rotary Club regarding volunteer firefighting. 3 apparatus now being stored at the town hall. Chair Jacobs brought up question if training on the AED could be part of the CPR and First Aid class that maybe possibly held at the town hall. Answer to question was yes.

Mobile Home Park Renewals: 3 Mobile Home parks are up for renewal. Coulee Manor; 20 lots with 16 occupied and fee \$100.00. Golden Valley; 50 lots with 49 occupied and fee \$250.00. Brook View; 94 lots with 93 occupied and fee \$465.00. These fees have remained the same for the last couple of years. No complaints received about any of the parks. Clerk will find out if town fees are consistent with other towns and will adjust if needed at this time next year. Motion by Jacobs/Neubauer to approve renewals. **Motion** carried unanimously.

Roads: Town will try to use ARPA funds for paving of Clements Road. Roads still needing repairs from past flooding are: Betz @ \$36,000, Schieche @ \$99,000. Working with DNR and DOT on Schmaltz Rd. to move the drainage ditch to the east. Bridge on Breidel Coulee Rd. will be replaced with a used culvert with est. cost of \$26,000. Paving Christianson Rd.@ \$26,000 and Kammel Coulee@ \$19,000. Estimated paving total \$208,000. Budgeted \$278,000 for this year. Still working on Clement Road land transfers. Rd. needs to meet specs in order to apply for federal grants. Resident Tom Hilleshiem stated he will not relinquish any of his property until the road is placed where it is permanently going to be.

Citizen Concerns: Speed bumps need to be put out this week. 2 sets to be located in front of the park. 4-way Stop signs to be placed at Ridgeview & Schams and Hess & Schams per Traffic & Safety committee's recommendations last year.

Motion by Timm/Neubauer to adjourn. Motion carried unanimously. Adjourned at 7:27 p.m.
